Dear Phi Delta Theta,

Based on the information available, Phi Delta Theta Fraternity acknowledges that the Louisiana Beta Chapter engaged in behavior on September 13, 2017, which violated of LSU's Code of Student Conduct, specifically violations of the alcohol, hazing and endangerment policies, as well as PS-108 and PS-78. As a result, Phi Delta Theta Fraternity, Inc. ("Phi Delta Theta") and the Louisiana Beta Chapter have agreed to accept the following outcome:

RESCISSION OF UNIVERSITY REGISTRATION - Effective Immediately through December 31, 2032

As a result of the incident that occurred on September 13, 2017 involving the Louisiana Beta Chapter of Phi Delta Theta, the University rescinds the registration of Phi Delta Theta at LSU, effective immediately, and continuing through no earlier than December 31, 2032. The University will also ask that any national charter or affiliation that the organization has be revoked immediately. During this time, neither Phi Delta Theta nor any local affiliate of Phi Delta Theta may:

- sponsor, cosponsor, or participate in any social, intramural, athletic, or other similar activities on or off campus;
- solicit any new members or pledges;
- initiate any new members;
- occupy or utilize any leased University property unless and until the organization returns as a registered student organization in good standing.

No request for reinstatement of registration will be considered prior to January 1, 2033. No pledges or initiated members from the 2017-2018 roster may be affiliated with any undergraduate chapter which may be reinstated in the future. Any evidence of an underground pledge class group in the name of Phi Delta Theta, or any affiliation with the fraternity and/or alias' during the time of rescission, may result in the extension of the time of University rescission.

Phi Delta Theta further agrees to the following stipulations:

1. Prior any request to return, Phi Delta Theta must have a zero balance owed to the University for any outstanding debt.
2. Prior to any request to return, an alumni chapter advisory team must be selected and approved by Phi Delta Theta Fraternity and the University.
3. No socials, on or off campus, sponsored or co-sponsored by any perceived Phi Delta Theta third

party that would represent the Phi Delta Theta undergraduate chapter may be held through January 1, 2033. This will include, but is not limited to, participation of any undergraduate Phi Delta Theta chapter attempting to represent Phi Delta Theta on the LSU campus or LSU associated events.

4. Prior to any request to return, the organization must meet with the Office of the Dean of Students to develop and agree upon a two year Enhancement Plan to ensure the chapter's successful reintegration into LSU's Greek community. Successful development of the Enhancement Plan is a pre-requisite for Phi Delta Theta's reinstatement as a registered student organization.
5. Prior to any reinstatement, Phi Delta Theta must be in compliance with the IFC Expansion Policy and Greek Life New/Returning Fraternity and Sorority Expansion/Re-Organization/Re-Chartering/Re-Activation Policy.
6. In the event of reinstatement, the alumni chapter advisory team members must attend an educational session approved by LSU Greek Life, on the topic of alumni advising, on an annual basis for the four (4) academic years following re-organization. In advance of the educational session, Phi Delta Theta must provide agenda topics, content related to the expectations related to being an advisor of the chapter, and the presenter of the educational session to LSU Greek Life for approval.

As the designated representative of Phi Delta Theta Fraternity, I accept and agree to oversee the completion of the listed sanctions on behalf of my organization. I agree to communicate all aspects of this document to all the members of my organization including, but not limited to advisers, alumni, National representatives, etc. I also understand that further violations of the LSU Code of Student Conduct by the Louisiana Beta chapter of Phi Delta Theta will result in further accountability action and may further jeopardize the organization's status with the University.
